The Programme

The LLB & BBAAC double degree programme (admission code: JS1062) is an undergraduate degree for students interested in accountancy and legal education and practice. It provides you with the required skills to graduate with a qualifying LLB degree and an undergraduate degree in accountancy. The double degree takes 5 years in total instead of the 8 years the two separate degrees would take.

The graduates benefit from a rigorous legal education combined with solid academic training in accounting within a global business mindset. Graduates will be highly sought after for positions in the commercial and financial sectors. The programme is also suitable for students aiming for a range of other careers where combined legal and accountancy knowledge is an advantage.



Programme structure

To graduate, LLB & BBAAC students must complete 150 credit units comprising core law courses, law electives, accounting and business courses and Gateway Education courses such as English Language courses and Chinese Civilisation courses.

The core courses for LLB & BBAAC students include Legal Methods, Research and Writing, Hong Kong Legal System, Law of Contract, Law of Tort, Constitutional Law, Administrative Law, Criminal Law, Land Law, Company Law, Public Law of the PRC, Private Law of the PRC, Introduction to Financial Accounting, Taxation and Tax Planning, Corporate Finance and Control, Corporate Accounting and Auditing.

Students contemplating entry to the legal profession must also study Equity and Trusts, Law of Evidence and Commercial Law.

Special Features

- ◆ Legal placements at law firms, international companies, banks and NGOs in Hong Kong.
- ◆ Opportunities to participate in Global Legal Education and Awareness Project (G-LEAP) and study for a month-long intensive course at University College, Oxford (reconfirmed every 2 years).
- ◆ Extensive training and financial support for students to participate in international mooted competitions.
- ◆ Exciting exchange opportunities at leading universities around the world.
- ◆ The University offers various types of scholarships and prizes in recognition of students' achievements or for the financial support to students in need.
- ◆ Opportunities to edit CityU Law Review, one of the academic journals led by the CityU School of Law.
- ◆ Guest lectures by scholars from top overseas law schools or legal institutions.



Career Prospects

Graduates may pursue further studies or professional qualifications. Students who complete Law Major and specific prerequisites elective courses will satisfy the requirements stipulated by the Standing Committee on Legal Education and Training to apply for admission to Postgraduate Certificate in Laws (PCLL).

We have engaged with the Professional Bodies in a process to gain the same professional accreditation as the Bachelor of Business Administration in Accountancy programme. (Subject to the successful completion of the prescribed courses and periodic review by respective professional bodies).

Admission Requirements

JUPAS Applicants

To be eligible for admission to the Double Degree Programme (JS1062), HKDSE applicants should achieve Level 5 or above in English Language, Level 3 or above in Mathematics and satisfy the University general entrance requirements. Direct / Non-JUPAS Applicants

To be eligible for admission, you must satisfy the General Entrance Requirements and meet the following programme specific entrance requirements:

- ◆ an overall band score of 7 in IELTS#; or
- ◆ a TOEFL# of 600 (paper-based test) OR 100 (internet-based test); or
- ◆ Grade C or above in HKALE AS Level Use of English; or
- ◆ other equivalent qualifications

Obtained within three years before admission.

Applicants may apply for admission to the programme directly. Advanced standing entry will not be considered.

Mature local applicants are eligible to apply for admission to first-year study even if they do not satisfy the minimum entrance requirements. Please visit <https://www.cityu.edu.hk/admo/admissions/non-jupas-year-1-admission>

Mature applicants must be over the age of 25 by 1 September of the year of admission and be able to demonstrate their aptitude and suitability for study.
