## Part II Course Details

### 1. Abstract

This course aims to provide intensive, simulation-based, practical instruction in the skills required for effective participation in the arbitration process. Upon completion of the Course, the student should be able to demonstrate a minimum standard of competence in a range of skills required in the arbitral process whether as advocate, expert witness, or arbitrator. The course will further innovate a student's ability to understand the fundamental concepts with the ultimate goal of discovering how to write an enforceable arbitral award.

#### 1. Keyword Syllabus

Arbitral Process. Practical Instruction. Simulation-based. Range of Skills.

##### 1.1. Detailed Syllabus

The tutorial sessions will invite practicing arbitrators, mainly in Hong Kong, to take part as tutors. Students will be divided into groups of around 10. In the tutorial, the students are encouraged or compelled to make oral submissions, applications and procedural decisions. It is intended to be practical and genuine, with students being guided by practicing arbitrators. It is believed that after this course, the students should be able to meet the intended learning outcomes set out in Module 3A and B of CIArb. The tutorial sessions (each of 3 hours) will cover areas like:

- The preliminary meeting.
- Discovery and inspection of documents.
- Interlocutory proceedings (1) & (2).
- Challenge to jurisdiction.
- Expert evidence.
- The hearing.
- Document-only arbitration.
- Decision-making.
