Panel Discussion 1: Rethinking the future of legal education (chaired by Dean HKU)

Four panel members will lead the discussion, each speaking for 5 minutes on the following sub-topics of their choice, followed by general discussion:

1. Do you foresee re-designing the curriculum for legal education at undergraduate, postgraduate and doctoral levels? Would there be more inter-disciplinary components in legal education, given that COVID 19 has demonstrated the need for graduates to be prepared for having a broader set of skills in view of the challenging environment for employment?
2. How can law schools better prepare the graduates for the real world, whether it is for employment or good graduate programme?
3. Would there be more emphasis on student learning outside the classroom, such as competitions, internships and other forms of experiential learning, particularly at the undergraduate and taught postgraduate levels?
4. How can we better leverage technology in delivering legal education?

Panel Discussion 2: Rethinking the future of law schools in Asia (chaired by Dean CityU)

Four (TBC) panel members will lead the discussion, each speaking for 5 minutes on the following sub-topics of their choice, followed by general discussion:

1. How would COVID 19 will impact the future of mutual co-operation and collaboration among the law schools in Asia in terms of research and teaching?

2. How would COVID 19 impact research direction, how research is to be evaluated and how to measure the research impact on society? For example, would there be more interdisciplinary research conducted given that problems are going to be multi-faceted and more complex? Do you foresee the pressures on funding sources and how would such gaps be addressed?
3. Are there stakeholders (such as the legal profession, employers, funding agencies, education bureau) who require changes in the way legal education is delivered? What are your thoughts on their views?
