- 5. If you place HKU/CUHK as your first choice in your PCLL application, your application will not be considered until you tell us that your application has been rejected by them. Please note that by the time you produce a letter of rejection from HKU/CUHK, there might not be any places available at CityUHK. We will first consider the first choice applications and will review the second and third choice applications only if there are any places left.
  - You must select only <u>one</u> institution as your first preference. If you place CityUHK as your first preference in your application to CityUHK <u>and</u> place HKU/CUHK as your first preference in your applications (whether full-time or part-time or both) to them, you will be disqualified by all three PCLL providers.
- 6. Applicants are allowed to change their first choice institution but are required to provide written consent (confirmation) from their original first choice institution. Any change of preference will be considered in late August 2025 if places are still available. Requests for a change of preference must be sent directly to the School of Law.

- 7. Please supply academic transcripts and/or other appropriate evidence
  - that you have satisfactorily completed an LLB or JD or GDL or ADLE or equivalent with passes in all nine core subjects, namely Contract, Tort, Constitutional Law, Criminal Law, Land Law, Equity, Evidence, Business Associations and Commercial Law, and (where applicable) three top-up subjects, namely Hong Kong Constitutional Law, Hong Kong Land Law and Hong Kong Legal System (for overseas students, you must provide a copy of the evaluation (exemption) letter issued by the Hong Kong Conversion Examination Board and your PCLL conversion exam results); and
  - (b) that you have obtained 7 or above overall band score in the International English Language Testing System (IELTS-academic) from a test taken at the IELTS test centre no more than 3 years before the closing date of application (i.e. 30 April 2025). This is a requirement of the Standing Committee on Legal Education and Training in Hong Kong. No exemption will be granted.

You may apply for the PCLL pending the completion of your law programme or any core subject (e.g. final year LLB/JD students may apply although their final exam results may not be available until after the close of applications). You are required to upload the documents once they are available onto the admission on-line system and send by post a copy to School of Law. Any conditional offer made to enrol in our PCLL programme is subject to your achieving those conditions (applicants are required to provide documentary evidence of achieving those conditions) within the deadline given.
- 9. Please note that if your application is successful you are expected to attend our PCLL "Orientation Day" in late August and all PCLL classes starting in <u>early September</u> on time. By signing and submitting this form you acknowledge and agree to this.
- 10. CityUHK School of Law offers both UGC-funded and self-financing PCLL places. The UGC-funded places are limited in number and are awarded on the basis of merit subject to relevant or applicable regulations. Students who are given the self-financing places may subsequently be considered for UGC-funded places in August-September 2025.

The allocation of UGC-funded places is primarily aimed at local applicants demonstrating exceptional academic achievements. For non-local students, the assignment of these funded places is entirely at the discretion of our programme, influenced by a variety of factors specific to each year's applicant pool. Consequently, there is no assured correlation between academic excellence and the allocation of a UGC-funded place for non-local applicants.

The tuition fees for 2025/26 **UGC-funded** places are HK\$44,500 for local students and HK\$170,000 for non-local students (which are subject to review from time to time). The tuition fee for 2025/26 **self-financing** places is HK\$7,700 per credit unit.
